

Staff recommends that the City Council conduct a public hearing and approve and authorize the City Manager to execute the Second Amendment to the Exclusive Agreement Between the City Of Hawthorne, in the County of Los Angeles, CA and Redflex Traffic Systems, Inc. for Photo Red Light Enforcement Program, and approve a corresponding blanket purchase order in the amount of \$240,000 to the vendor.

DISCUSSION:

In 2003, the City of Hawthorne entered into an agreement with Redflex Traffic Systems, Inc. to begin a Photo Red Light Enforcement Program. This enforcement program currently encompasses approaches at four intersections within the City.

In April, 2009, a new Exclusive Agreement Between the City of Hawthorne, in the County of Los Angeles, CA and Redflex Traffic Systems, Inc. for Photo Red Light Enforcement Program was entered into.

In March, 2012, the City of Hawthorne and Redflex Traffic Systems, Inc. approved Amendment No. One to the Exclusive Agreement of April 2009.

Approval of the proposed Second Amendment to the agreement of April, 2009 will extend the term of the Exclusive Agreement of April, 2009, through the end of FY 2023/24.

The red light photo enforcement program addresses a specific issue (red light violations) at each location where it is in place, 24 hours a day, seven days a week. The table below illustrates figures obtained from the red light photo enforcement program for two calendar years, 2005 and 2018. These years were selected because:

2005 represents the first full calendar year for which the red light photo enforcement program was running at all four intersections.

2018 represents the most recent full calendar year for which figures related to the red light photo enforcement program are available.

- Incidents Reviewed: Total number of possible red light camera violations processed by Redflex Traffic Systems, Inc., and submitted for review to Hawthorne Police Department staff.
- Notices Printed: Total number of actual citations combined with requests for information issued at the direction of Hawthorne Police Department staff after reviewing the incident.
- Citations Issued: Total number of citations issued.

While the actual number of citations issued increased between 2005 and 2018, the total number of potential violations actually decreased 22.4%. This is indicative of an effective traffic education program. Many motorists consistently drive the same route on a daily basis based on their routines (work commutes, school, etc.). The decrease in potential violations from 2005 to 2018 shows that these consistent drivers are aware of the red light cameras at the four intersections covered by the program, and have adjusted their driving habits accordingly.

Beginning with calendar year 2004 and ending with calendar year 2018, there have been in excess of 300,000 citations issued via the red light photo enforcement program. Only 6% of persons who have received a citation from the program have received two or more from the City's program. The program is effective at educating the public about laws governing red lights.

Despite the drop in overall possible violations depicted in the table above, there continues to be a sufficient amount of violations occurring to warrant continuation of the program at the current

locations. The presence of the program in these high volume travelled areas allows for staff to be assigned elsewhere throughout the City to address other traffic related problems.

FISCAL IMPACT:

None. Funds are available in the current fiscal year's adopted budget.

SECOND AMENDMENT TO EXCLUSIVE AGREEMENT BETWEEN THE CITY OF HAWTHORNE, IN THE COUNTY OF LOS ANGELES, CA AND REDFLEX TRAFFIC SYSTEMS, INC. FOR PHOTO RED LIGHT ENFORCEMENT PROGRAM

This Second Amendment (the "Second Amendment") to Agreement between the City of Hawthorne, CA and Redflex Traffic Systems, Inc. for Photo Red Light Enforcement Program is made by and between the City of Hawthorne, CA (the "Customer" or the "City"), and Redflex Traffic Systems, Inc. ("Redflex") (individually referred to as a "Party" and together referred to as the "Parties"). The Effective Date of this Second Amendment is December ______, 2020.

RECITALS

WHEREAS, the Parties executed the Exclusive Agreement between the City of Hawthorne, CA and Redflex Traffic Systems, Inc. for Photo Red Light Enforcement Program on April 19, 2009 (the "Original Agreement");

WHEREAS, the Agreement was amended on March 3, 2012 to make changes and improvements to Sections 2, 3.3.10, 6.1, 6.2, 6.3 and Exhibits "A" and "D" (the "First Amendment") (collectively, with the Original Agreement, the "Agreement");

WHEREAS, Except as otherwise specifically amended herein in this Second Amendment, all other terms and conditions contained in the Agreement shall remain in full force and effect;

WHEREAS, the Parties now desire to extend the Term and update the Notice address of the Agreement; and

NOW THEREFORE, the Parties hereby amend the Agreement as follows:

TERMS AND CONDITIONS

- **A.** <u>Term.</u> Section 2, "Term," of the Agreement is hereby replaced in its entirety with the following language:
 - 2. TERM. The term of this Agreement shall commence as of the Effective date of this Second Amendment and shall continue until June 30, 2024. The Customer shall have the right, but not the obligation, to extend the term of this Agreement for up to one (1) additional four (4) year period following the expiration of the Initial Term ("Renewal Term" and collectively with the Initial Term, the "Term"). The Customer may exercise its right to extend the term of this Agreement for a Renewal Term by providing written notice to Redflex not less than thirty (30) days prior to the last day of the Initial Term. In the absence of such notice to extend the Term of this Agreement, the Term shall be automatically extended from month to month until either (1) the City or Redflex terminate this Agreement upon thirty (30) days written notice or (2) the Parties enter into a new agreement.
