The Court received your record request dated May 12, 2019 on June 10, 2019. In it, you requested the following;

This is a brand new request for records. first filed by email on 6-2-19 and then postal mailed on 6-3-19.

I would like to obtain photocopies of the checks (or another document providing the amount distributed), which the Court wrote to distribute money to the City of Beverly Hills. or the City of Commerce, or the City of Covina, or Culver City, or the City of Hawthorne, or Metro/MTA. or the City of Montebello, or the City of West Hollywood and which were written during the period Jan. 1. 2019 to the present. as well as photocopies of any explanatory materials that would have been distributed along with those checks and any explanatory materials that the Court created in association with the writing of those checks but which were retained by the Court and not distributed.

I made a similar request. albeit covering fewer cities. on February 12 and am attaching. to serve as an example of the document(s) I am requesting, the record the Court sent me in response to that request.

The information requested will be utilized for a journalistic purpose.

As stated previously, checks to cities are generated by the County, not the Court, and are based on the Court's monthly report. As such, the Court does not retain copies of the checks. However, the enclosed document provides the amounts distributed to cities from January 1, 2019 to the present. Processing charges are waived due to electronic delivery.
