The January 26, 2016, Regular Meeting of the City Council of the Chartered City of Vista, the Community Development Commission of the City of Vista, the Buena Sanitation District, and the Successor Agency to the Vista Redevelopment Agency, was called to order by Mayor Ritter at 5:33 p.m. in the City Council Chambers, 200 Civic Center Drive, Vista, California.

# USE OF DRONES (CC)

Deputy Mayor Rigby introduced the item and stated her concerns regarding the use of drones as it relates to an invasion of privacy.

Councilmembers and City Attorney Pieper discussed existing federal, state and local legislation governing the use of drones.

#### RED LIGHT PHOTO ENFORCEMENT PROGRAM (CC)

Deputy Mayor Rigby presented the report.

Deputy Mayor Rigby and Councilmember Franklin stated their opposition to the Red Light Photo Enforcement Program and the current vendor, Redflex Traffic Systems, Inc.

Mayor Ritter and Councilmembers Aguilera and Campbell voiced their support of the program, stating improved traffic safety in the targeted intersections.

City Manager Johnson introduced City Engineer Greg Mayer and Principal Engineer Sam Hasenin who responded to questions from the Council. Principal Engineer Hasenin stated that timing on the City's yellow lights follows the state standards, which was recently extended. He also confirmed that the City uses "four-way red lights" at intersections.

MOTION BY RIGBY, SECOND BY FRANKLIN, TO DIRECT THE CITY MANAGER TO ALLOW THE CONTRACT WITH REDFLEX TO LAPSE IN MAY AND TO NOT RENEW THE CONTRACT WITH REDFLEX TRAFFIC SYSTEMS, INC.

NO VOTE TAKEN, DISCUSSION CONTINUED, FOLLOWED BY A SUBSTITUTE MOTION BY COUNCILMEMBER CAMPBELL.

MOTION BY CAMPBELL, SECOND BY AGUILERA, TO DIRECT THE CITY MANAGER TO EXERCISE THE CITY'S SECOND TWO-YEAR OPTION WITH REDFLEX TRAFFIC SYSTEMS, INC. AND TO EVALUATE OTHER COMPANIES THAT PROVIDE SUBSTANTIALLY THE SAME SERVICE FOR FUTURE CONSIDERATION.

MOTION CARRIED 3-2, RIGBY AND FRANKLIN OPPOSED.
