1. The contract with the red light camera vendor, Redflex, is on file at City of Modesto clerk's office and will be included with this request. - Emailed to you.
2. The location/date of installation of each red light camera within the City of Modesto in the last ten years.

3. Evidence that the City of Modesto complied with 21455.5 (b) CVC, by issuing only warning notices for 30 days following commencement of operation of each red light camera.

I am unable to provide copies of the warning citations pursuant to 21455.4 (e) CVC. They were destroyed pursuant to 21455(e)(3) CVC. I did provide a copy of the warning cite that was sent to violators. The following are the activation dates and the 30-days warning cites were issued.

a. Standiford Ave / Sisk Rd

Start date: 03/01/05 warning cites issued until 03/31/05

b. Standiford Ave / Tully Rd

Start date: 03/25/05 warning cites issued until 04/24/05.

c. Briggsmore Ave / Oakdale Rd

Start date: 06/20/05 warning cites were issued until 07/20/05

d. Briggsmore Ave / Prescott Rd

Start date: 06/30/05 warning cites were issued until 07/30/05

e. Sylvan Ave / Coffee Rd

Start date: 04/05/07 warning cites were issued until 05/04/07.

4. Evidence that the City of Modesto complied with California Vehicle Code section 21455(b), by making public announcement of the automated traffic enforcement system at least 30-days prior to commencement of operation of each red light camera.

I provided copies of the Modesto Bee and Police Department press releases. Here is a summary of each intersection and corresponding articles:

Standiford Ave / Sisk Rd went live warning notices on 03/01/05. Citations were issued starting 04/01/05. I have provided copies of the Modesto Bee articles or press releases dated 02/18/05, 02/23/05, 02/28/05 and 03/02/05 covering this intersection and the use of red light cameras.

Standiford Ave / Tully Rd went live for warnings notices on 03/25/05. Citations were issued starting 04/25/05. I have provided copies of the Modesto Bee articles or press releases dated 03/25/05 and 04/13/05.

Briggsmore Ave / Oakdale Rd went live for warning notices on 06/20/05. Citations were issued starting 07/21/05. I have provided copies of the Modesto Bee articles or press releases dated 06/21/05.

Briggsmore Ave / Prescott Rd went live for warning notices on 06/30/05. Citations were issued starting 07/31/05. I have provided copies of Modesto Bee articles or press releases dated 06/21/05.

Coffee Rd / Sylvan Ave went live for warning notices on 05/04/07. Citations were issued starting 06/05/07. I have provided copies of Modesto Bee articles or press releases dated 04/03/07, 04/04/07 and 05/02/07.

5. Evidence that the City of Modesto' contract with any and all manufactures or suppliers of automated traffic signal enforcement equipment complies with 21455.5 (g) (1), CVC.

Page 28 Exhibit "D" of the Redflex contract with the City of Modesto states in part "Fixed fee of \$6,030 per month system (intersection approach) as full remuneration for performing all of the services completed in this agreement.

6. Evidence that the City of Modesto's contract with any and all manufacturers or or suppliers of automated traffic signal enforcement equipment complies with 21455.5 (g) (2), CVC.
  - a. This vehicle code section does not apply to our contract since it went into effect after January 1, 2004.
