Subject: Redflex Camera Contract Extension

**ISSUE STATEMENT:**

Authorize the City Manager to sign a month-to-month contract extension, until no later than August 31, 2014, with Redflex Traffic Systems, Inc.

**DISCUSSION:**

The current contract with Redflex Traffic Systems, Inc. expires June 17, 2014. The Police Department would like to continue uninterrupted camera services with Redflex while it conducts analysis on the effectiveness on the Red Light Camera Program and continues negotiations with Redflex Traffic Systems, Inc. for possible future services. A month-to-month contract extension, utilizing the current contract terms and not to exceed three months, is acceptable to Redflex Traffic Systems and would meet the needs of the Police Department.

The Police Department is in the process of conducting deeper analysis into the effectiveness of the Red Light Camera Program since its inception and preparing a comprehensive report for the City Council on its findings. This report will look to see if there is a correlation between signal controlled intersections and changed driving behaviors. Effectiveness will be determined by the number of violations occurring at those intersections where a red light camera exists, the number of collisions pre-installation of the red light cameras and the number of collision post installation and whether the program is fiscally self-sustainable. This report will be completed within the next 30 days.

In the event the Red Light Camera Program is found to be effective, the Police Department is currently negotiating with Redflex Traffic Systems, Inc. to establish different contract options for the Council to consider. The options being explored would be contract terms of one year, three years or five years with different price points depending on length of term. It will be the intent of the Police Department to continue with the City's ability to terminate the contract without cause at any time by giving a ten day written notice to terminate, regardless of the chosen term of the contract.

RE: **Term Extension of June 13, 2008 Agreement**

Dear Chief of Police Melton and Administration Captain Troendly:

This letter is to confirm the Parties' agreement to extend the Term provided for in Section 5 of the June 13, 2008 Agreement between the City of Napa and Redflex Traffic Systems Inc. for Automated Photo Enforcement Cameras (the "Original Agreement") which Original Agreement was amended in the July 21, 2011 and June 11, 2012 Amendments and extended in the City's June 17, 2013 letter (collectively, the "Agreement"). Specifically, the Parties agree that the Term shall be extended on a month-to-month basis until the earlier of (1) termination, (2) the Parties enter into a new or renewal contract for automated photo enforcement cameras, or (3) August 31, 2014; provided, however, that either Party may terminate this extension upon thirty (30) days written notice to the other Party.

Except as expressly modified in this letter, all provisions of the Agreement shall remain in full force and effect.
