

**DO NOT CALL THE COURT REGARDING THIS NOTICE.**

DMV records indicate that you are the Registered Owner of the vehicle depicted in the citation images committing a traffic violation in the City of Newark.

- California Vehicle Code 40518 requires you respond to this notice within **30 days**. You must complete all the information in the bottom section and return the completed form.
- This information is required even if you were the driver of the vehicle.
- **IF** you **WERE** the driver, check the appropriate box and fill in the form completely.
- If you have sold the vehicle, or were not the driver at the time of the violation, please check the appropriate box below.
- California Vehicle Code 14606 requires a person who allows someone to drive their vehicle verify that the person being given permission has a current license to drive that class of vehicle being operated.
- An electronic version of your vehicle insurance is now maintained with DMV. Failure to identify the driver could result in notifications being made to the insurance carrier.
- **FAILURE TO RESPOND TO THIS NOTICE COULD RESULT IN A CITATION BEING ISSUED IN YOUR NAME. THIS PROCESS COULD EFFECT YOUR DRIVERS LICENSE STATUS AND REQUIRE YOU TO APPEAR IN COURT.**
